1 For its petition pursuant to the California Public Records Act (Government Code §§ 6250,
2 *et seq.*), Plaintiff hereby alleges:

3 **PARTIES**

4 1. Plaintiff PRISON LEGAL NEWS (“PLN”) is a project of the Human Rights
5 Defense Center, a Washington state 501(c)(3) non-profit corporation. PLN publishes a monthly
6 journal entitled "Prison Legal News," and also publishes, sells and distributes books on a variety
7 of criminal justice and human rights and self help issues. It is a “person” and a “member of the
8 public” within the meaning of Government Code §§ 6252(c) and 6259(a).

9 2. Defendant CITY AND COUNTY OF SAN FRANCISCO is a “local agency”
10 within the meaning of the California Public Records Act, Government Code § 6252(a).

11 3. Defendant MICHAEL HENNESSEY is the Sheriff of San Francisco County.
12 Defendant Hennessey is sued in his official capacity.

13 4. Defendant SAN FRANCISCO SHERIFF’S DEPARTMENT is a “local agency”
14 within the meaning of the California Public Records Act, Government Code § 6252(a).

15 5. Defendant DENNIS HERRERA is City Attorney for the City and County of San
16 Francisco. Defendant Herrera is sued in his official capacity.

17 6. Defendant SAN FRANCISCO CITY ATTORNEY (“City Attorney”) is a “local
18 agency” within the meaning of the California Public Records Act, Government Code § 6252(a).

19 **JURISDICTION AND VENUE**

20 7. Venue is appropriate in this Court, because Plaintiff may “institute proceedings for
21 injunctive or declaratory relief or writ of mandate in any court of competent jurisdiction to
22 enforce his or her right to inspect or to receive a copy of any public record or class of public
23 records.” Government Code § 6258.

24 **FACTS**

25 8. PLN publishes a monthly magazine, “Prison Legal News,” and also distributes
26 books and other materials pertaining to the legal rights of prisoners and the conditions affecting
27 them. “Prison Legal News” is comprised of writings from legal scholars, attorneys, inmates and
28 news wire services. PLN has approximately 7,000 subscribers in the United States and abroad,

1 including subscribers in jails and prisons across the country and subscribers in the City and
2 County of San Francisco. The purpose of PLN, as stated in its Articles of Incorporation, Article
3 III, Part 6 is “to educate prisoners and the public about the destructive nature of racism, sexism,
4 and the economic and social costs of prisons to society.”

5 9. On July 9, 2008, Plaintiff, through its attorneys, sent a Public Records Act request
6 pursuant to California Government Code §§ 6250, *et seq.*, to Defendant Hennessey. The letter,
7 attached hereto as **Exhibit 1**, included two requests for specific documents relating to tort,
8 overdetention, and civil rights claims filed against the City and County of San Francisco. The
9 documents requested are “public records” within the meaning of Government Code §§ 6252(e).
10 The request stated that the Public Records Act required a response within 10 days of the request.

11 10. On July 15, 2008, Plaintiff received a letter from Defendant Hennessey stating that
12 he was forwarding the request to the City Attorney “because we are not the archivists of the
13 documents you have requested and there may be confidentiality issues with respect to payout
14 settlements.” That letter is attached hereto as **Exhibit 2**.

15 11. Defendant City Attorney did not respond to the request.

16 12. On November 26, 2008, Plaintiff sent a letter to Defendant City Attorney following
17 up on the July 9, 2008 request. That letter is attached hereto as **Exhibit 3**.

18 13. On December 1, 2008, Plaintiff’s counsel received a telephone call from Joanne
19 Hoeper at Defendant City Attorney’s office stating that the office had no record of the July 15,
20 2008 request. However Ms. Hoeper promised that an attorney in her office would contact
21 Plaintiff’s counsel within one week and would produce a spreadsheet of payments for Plaintiff to
22 review and use in determining which documents it continued to seek.

23 14. On December 17, 2008, Defendant City Attorney produced a spreadsheet including
24 information on file names, file numbers, expense amounts, settlement amounts, and hourly
25 amounts from 722 different cases. That spreadsheet is attached hereto as **Exhibit 4**.

26 15. On January 9, 2009, Plaintiff sent a letter to Defendant Herrera seeking
27 confirmation that the spreadsheet produced contained all records encompassed by the original
28

1 request and seeking production of the underlying documents for certain cases. That letter is
2 attached hereto as **Exhibit 5**.

3 16. On January 30, 2009, Defendant Herrera sent Plaintiff a letter stating that the
4 spreadsheet produced “was a compilation of possible matters responsive to your request.” The
5 letter further stated that the spreadsheet “does not purport to be all encompassing.” In addition,
6 Defendant Herrera requested that Plaintiff provide case numbers for the documents it sought and
7 suggested that Plaintiff attempt to gather the documents it sought through court files. That letter
8 is attached hereto as **Exhibit 6**.

9 17. On March 27, 2009, Plaintiff sent Defendant Herrera a letter stating that it “agreed
10 to the production of the spreadsheet as an interim, less burdensome method for production of
11 information to help us determine which documents included in our original request we continue
12 to seek.” In addition, Plaintiff noted, “If you do not produce a spreadsheet that contains all
13 claims detailed in the original request, we cannot rely upon that spreadsheet to narrow our
14 request for documents.” In response to Defendant’s request that Plaintiff provide case numbers
15 for the documents it sought, Plaintiff attached a list of case numbers. Finally, Plaintiff stated that
16 it would not seek the requested documents from the court file. That letter is attached hereto as
17 **Exhibit 7**.

18 18. Also on March 27, 2009, Plaintiff sent a new Public Records Act Request seeking
19 to update its initial July 2008 request and requesting comparable documents for the period since
20 July 9, 2008. In addition, Plaintiff’s new Public Records Act Request sought the dates of the
21 Board of Supervisors meetings at which settlements referenced in either the July 2008 request or
22 the new request were approved.

23 19. To date, Defendants have not responded to either of Plaintiff’s March 27, 2009
24 letters.

25 **FIRST CLAIM FOR RELIEF (California Public Records Act)**

26 20. Plaintiff re-alleges and incorporates herein by reference each and every allegation
27 of paragraphs 1 through 19.

1 21. The requested documents and information consist of “public records” within the
2 meaning of Government Code § 6252(e), and such records are within the possession, custody or
3 control of the Defendants.

4 22. The documents and information requested are not exempt from public disclosure.

5 23. Plaintiff has the right to inspect and obtain copies of the information and
6 documents requested. Government Code §§ 6253(a) and (b).

7 24. “Public records are open to inspection at all times during the office hours of the
8 state or local agency and every person has a right to inspect any public record,” except those
9 within the Act’s specifically enumerated exceptions. Government Code § 6253(a).

10 25. Upon receipt of a Public Records Act Request, an official such as Defendant City
11 and County of San Francisco, “shall, within 10 days from receipt of the request, determine
12 whether the request, in whole or in part, seeks copies of disclosable public records in the
13 possession of the agency and shall promptly notify the person making the request of the
14 determination and the reasons therefore.” Government Code § 6253(c).

15 26. Defendants were obligated “upon a request for a copy of records that reasonably
16 describes an identifiable record or records, [to] make the records promptly available to any
17 person....” Government Code § 6253(b).

18 27. The Public Records Act further provides that “any agency that has information that
19 constitutes an identifiable public record not exempt from disclosure pursuant to this chapter that
20 is in an electronic format shall make that information available in an electronic format when
21 requested by any person.” Government Code § 6253.9(a). When such electronic records are
22 requested and produced, “[t]he cost of duplication shall be limited to the direct cost of producing
23 a copy of a record in an electronic format.” Government Code § 6253.9(a)(2). The agency may
24 only charge for the costs of “programming and computer services” when such costs are
25 “necessary to produce a copy of the record.” Government Code § 6253.9(b).

26 28. Defendants have failed to comply with Government Code § 6253(c). Defendants
27 did not make a meaningful determination within 10 days of whether Plaintiff’s request “seeks
28 copies of disclosable public records in the possession of the agency” as required by Government

1 Code § 6253(c). In addition, Defendants have failed to respond at all to Plaintiff's March 27,
2 2009 request.

3 29. Defendants have failed to make the records "promptly available" as required by
4 Government Code § 6253(b).

5 30. Defendants have failed to comply with Government Code § 6253.9(a). Defendants
6 have not made the information already contained in their litigation tracking system available to
7 Plaintiff.

8 31. The records requested, as set forth in **Exhibits 1 and 7**, are being withheld from
9 Plaintiff by Defendants in violation of the California Public Records Act, Government Code
10 §§ 6250, *et seq.*

11 **SECOND CLAIM FOR RELIEF (San Francisco Sunshine Ordinance)**

12 32. Plaintiff re-alleges and incorporates herein by reference each and every allegation
13 of paragraphs 1 through 19.

14 33. San Francisco Administrative Code § 67.1(d) provides, "The right of people to
15 know what their government and those acting on behalf of their government are doing is
16 fundamental to democracy, and with very few exceptions, that right supersedes any other policy
17 interest government officials may use to prevent public access to information."

18 34. The requested documents and information consist of "public records" and/or
19 "public information" within the meaning of San Francisco Administrative Code § 67.20, and
20 such records are within the possession, custody or control of the Defendants.

21 35. Plaintiff has the right to inspect and obtain copies of the information and
22 documents requested under San Francisco Administrative Code § 67.21(a), which provides:
23 "Every person having custody of any public record or public information, as defined herein,
24 (hereinafter referred to as a custodian of a public record) shall, at normal times and during
25 normal and reasonable hours of operation, without unreasonable delay, and without requiring an
26 appointment, permit the public record, or any segregable portion of a record, to be inspected and
27 examined by any person and shall furnish one copy thereof upon payment of a reasonable copying
28 charge." San Francisco Administrative Code § 67.21(a).

1 36. A custodian of record such as Defendant City and County of San Francisco, “shall,
2 as soon as possible and within 10 days following receipt of a request for inspection or copy of a
3 public record, comply with such request.” San Francisco Administrative Code § 67.21(b).

4 37. The Sunshine Ordinance further provides, “Inspection and copying of documentary
5 public information stored in electronic form shall be made available to the person requesting the
6 information in any form requested which is available to or easily generated by the department, its
7 officers or employees . . . at a charge no greater than the cost of the media on which it is
8 duplicated.” San Francisco Administrative Code § 67.21(l).

9 38. “It is the policy of the City and County of San Francisco to utilize computer
10 technology in order to reduce the cost of public records management, including the costs of
11 collecting, maintaining, and disclosing records subject to disclosure to members of the public
12 under this section. To the extent that it is technologically and economically feasible, departments
13 that use computer systems to collect and store public records shall program and design these
14 systems to ensure convenient, efficient, and economical public access to records. . .” San
15 Francisco Administrative Code § 67.21-1(a).

16 39. The Sunshine Ordinance provides that the Defendant “[t]he San Francisco City
17 Attorney’s office shall act to protect and secure the rights of the people of San Francisco to
18 access public information and public meetings.” San Francisco Administrative Code § 67.21(i).

19 40. Defendants have failed to comply with San Francisco Administrative Code
20 § 67.21(b). Defendants did not comply with Plaintiff’s initial or March 27, 2009 request within
21 ten days.

22 41. Defendants have failed to comply with San Francisco Administrative Code
23 § 67.21-1(a). Defendants have not made the information already contained in their litigation
24 tracking system available to Plaintiff.

25 42. The records requested, as set forth in **Exhibits 1 and 7**, are being withheld from
26 Plaintiff by Defendants in violation of the San Francisco Sunshine Ordinance, San Francisco
27 Administrative Code §§ 67.20, *et seq.*

1 **PRAYER FOR RELIEF**

2 Wherefore Plaintiff respectfully prays, pursuant to Government Code § 6259:

3 1. For an order requiring Defendants to disclose the records requested, or an order to
4 show cause why they should not be required to do so.

5 2. For a declaratory relief judgment declaring that the requested records are public
6 records within the meaning of the provisions of the California Public Records Act, and are not
7 exempt from public disclosure.

8 3. For an injunction requiring that Defendants immediately permit the inspection and
9 to provide electronic copies of the requested records and document to the Plaintiff, with costs of
10 production to be borne by Defendants. Plaintiff remains willing, as an initial step, to accept a
11 comprehensive spread sheet of the claims and cases responsive to our request including the dollar
12 amounts paid out in connection to the judgments, settlements, and/or fees related to those claims
13 and cases to assist Plaintiff in determining which responsive documents it continues to seek.


14 4. For an order awarding Plaintiff its costs of suit and reasonable attorneys' fees
15 pursuant to Government Code § 6259(d), San Francisco Administrative Code § 67.35, and Code
16 of Civil Procedure § 1021.5.

17 5. For such further relief at this Court deems proper.



Dear Sheriff Harrigan:

This is a request on behalf of our client, Prison Legal News ("PLN"), pursuant to the California Public Records Act (California Government Code §§ 6250, *et seq.*) and the San Francisco Sunshine Ordinance (San Francisco Administrative Code, §§ 67, *et seq.*) for copies of public records in the possession of the San Francisco County.

Our request encompasses all the documents within the definition of the term "writing" as used in Cal. Gov't Code § 6252(g), including but not limited to all the specific documents listed below.

Specifically, we request:

1. All documents relating to payments resulting from tort, overdetention, and civil rights claims by prisoners, contractors, employees, and/or visitors at San Francisco County jails. This includes payments to claimants in the above cases and/or their attorney(s) pursuant to judgments and/or settlements by San Francisco County on behalf of itself and all of the branches, divisions, units, offices, and institutions under its control, or their agents, during the time period from January 1, 2002 to present. Such documents include but are not limited to:

- a. documents stating or pertaining to the legal claim that forms the basis for each judgment and/or settlement;
 - b. for each judgment and/or settlement, the most recent complaint detailing the legal demand;
 - c. for each judgment and/or settlement, any case management order detailing the legal demand;
 - d. all settlement agreements, and documents related to disbursement;
 - e. any record of the imposition of sanctions by a court, and payment thereof;
 - f. if payment was made pursuant to a judgment, the jury verdict and/or findings of fact and conclusions of law forming the basis for the judgment; and
 - g. any and all records of payment to plaintiffs, counsel, court officers, experts, Receivers, and/or Special Masters.
2. All documents relating to the costs San Francisco County has incurred on behalf of itself and all of the branches, divisions, units, offices, and institutions under its control, or their agents, in defense against tort and overdetection claims by claimants or litigants during the time period from January 1, 2002 to present.

The California Public Records Act requires determination of whether these records may be disclosed, and specific reasons why any material requested, or portions thereof, are exempt from disclosure, within ten days from receipt of this request. It also requires that San Francisco County promptly notify us of this determination, and of the estimated date and time when the records will be produced. In accordance with Cal. Gov't Code § 6253(c), we expect your response no later than July 21, 2008.

PLN is a 501[c](3) non-profit organization, responsible for the publication of a serious legal and political journal that reports on news and litigation involving detention facilities. We request production of these documents in electronic format whenever available, pursuant to Cal. Gov't Code § 6253.9 and San Francisco Administrative Code § 67.21(1). Wherever copying costs must be incurred, we request a waiver of these costs pursuant to the discretion conferred by Cal. Gov't Code § 6253.1. *See North County Parents Org. v. Dept. of Education*, 23 Cal.App.4th 144, 148 (1994) (ability to reduce fees inherent in power to "allow greater access to records"); *cf. Prison Legal News v. Lappin*, 436 F.Supp.2d 17 (D. D.C. 2006) (granting fee waiver for records request under Freedom of Information Act).



Dear Ms. Hoeper:

I am writing with regard to the public records request made on behalf of our client, Prison Legal News, pursuant to the California Public Records Act (California Government Code §§ 6250, *et seq.*) and the San Francisco Sunshine Ordinance (San Francisco Administrative Code, §§ 67, *et seq.*) for copies of public records in the possession of San Francisco County. The request was originally made in a letter addressed to the San Francisco County Sheriff's Department, dated July 9, 2008 (attached hereto as **Exhibit A**). In a letter dated July 15, 2008, Freya Horne, Assistant Legal Counsel to the Sheriff's Department (attached hereto as **Exhibit B**), stated that she was forwarding our request to your office.

As of today's date, we have not received any further response from your office or any one else on behalf of your office or the City and County of San Francisco. As stated in the original request, the California Public Records Act ("PRA") requires determination of whether the requested records may be disclosed, and specific reasons why any material requested, or portions thereof, are exempt from disclosure, within ten days from receipt of a request. Cal. Gov't Code § 6253(c). The PRA also requires that San Francisco County promptly notify us of this determination and of the estimated date and time when the records will be produced. *Id.* Accordingly, we expect your response no later than December 10, 2008.



County of Orange*, 158 Cal. App. 3d 893, 908-10 (1984).





The information was pulled from various data bases related to tort claims and litigation, and is a law office management tool. It does not purport all be all encompassing. For example, it does not include City employee matters like the 2004 Tory Lovett case.

There are 722 items on the spreadsheet. If you want records regarding certain matters, please identify the item number. We can only keep records on site for one year, so case files prior to 2008, are stored off-site and subject to a per box retrieval charge. - b. the verdict sheet, general release or settlement agreement setting out the amount paid by the county in the cases listed in **Exhibit A** hereto or any other case encompassed by the original request in which the total amount paid by the City and County of San Francisco exceeds \$1,000.

PLN will not attempt to obtain these documents from court files rather than through your office. Under the Public Records Act, it is the City's duty to "make the records promptly available." Gov't Code § 6253(b). If some of the documents are more easily available from court files than the City Attorney's archive, the City can compile the documents from the court files. Moreover, PLN seeks information regarding claims that were never filed as court cases as well as information regarding settlement payments that may not exist in court files.

To the extent that you suggest that the costs associated with retrieving boxes from storage are "direct charges" that might be billable to PLN, we note that the Public Records Act provides that you may only charge the "direct costs of duplication." *Id.* The California Court of Appeal has held that "'direct cost' does not include the ancillary tasks necessarily associated with the retrieval, inspection and handling of the file from which the copy is extracted." *North County Parents Org. v. Dept. of Ed.*, 23 Cal. App. 4th 144, 148 (1994). In any event, as stated in our previous letters, PLN requests a waiver of copying costs pursuant to the discretion conferred by Cal. Gov't Code § 6253.1. *See also North County Parents Org.*, 23 Cal. App. 4th at 148 (1994) (ability to reduce fees inherent in power to "allow greater access to records"); *Prison Legal News v. Lappin*, 436 F. Supp. 2d 17 (D.D.C. 2006) (granting fee waiver for records request under Freedom of Information Act). PLN is after all a 501(c)(3) non-profit organization.
