Maryland has a Division of Correction and the Patuxent Institution which houses the criminally insane. There are different security levels within an institution, as well as different types of physical structures. At our MD Correctional Institute - Jessup (medium security) there are approximately 1000 inmates in 6 housing units and 2 dormitories and a segregation unit. The housing units hold 128 inmates each and there are 2 correctional officers assigned to each housing unit, that is, one pod officer and one officer in charge (usually a Sergeant). The segregation unit is staffed with 5 correctional officers. The dormitories are staffed with one CO each.
