### C. SIGNIFICANT CASES, TRIALS or HEARINGS:

## 1. United States v. Dong Kyu Kim, Crim. No. ---- (EDPA)

On January 23, 1998, Judge Dalzell held a sentencing hearing for defendant Dong Kyu Kim. The defendant requested a downward departure from the sentencing guidelines of 10-16 months, alleging, as an alien, the Bureau of Prisons would treat him worse than a non-alien defendant. Hank Sadowski assisted the AUSA and advised the court of Bureau policy concerning

designations of deportable aliens and explained the rationale underlying it. The court's questions concerning

split sentences under Sentencing Guideline 5C1.1 were also addressed. The court decided that defendant did not warrant a downward departure from the guidelines and sentenced him to a 5 month term, 36 month supervised release, the first 5 months of which is in home detention. The AUSA felt the sentence was just.

# 2. <u>United States v. Luis Felipe</u>, No. 97-1155, 97-1484 (2d Cir.)

On January 22, 1998, the Second Circuit heard oral argument concerning the authority of a district judge to impose restrictions on conditions of confinement for Luis Felipe, 14067-074, the leader of the Latin Kings. The district court held that 18 U.S.C. § 3582(d) provided the court with jurisdiction to limit the defendant's contact with the outside world. The district court also held it had inherent authority to impose such restrictions. The AUSA advised that the Court of Appeals focused primarily on the 3582(d) jurisdiction prong. The Court of Appeals took the case under advisement.

## 3. <u>U.S. v. David Rosario</u>, 96-CR-126 (JFK) (S.D.N.Y.)

On January 5, 1998, Kevin McDonald, Health Services Administrator, MCC New York, testified during the above-captioned criminal matter. His testimony focused mainly on certifying copies of previously subpoenaed medical records. Clinton Stroble assisted the AUSA in preparing Mr. McDonald.

### 4. Starzecpyzel v. Reno, et. al., 3:97-CV-1081 (D. Conn.)

On February 17, 1998, a status conference is scheduled to discuss the numerous motions filed by attorney Stephen Roen on behalf of inmate Eileen Starzecpyzel, Reg. No. 34792-054. Roen is a New York City patent attorney, who has filed at least three requests for temporary injunction alleging harassment, right to represent his client at a UDC hearing, and visiting conditions. Recently, the District Court in Connecticut issued an order denying the TRO and suggesting that if the attorney continues to file TROs on these type of matters he would be sanctioned. Patty Gotts is assisting the AUSA.

1. Ramirez v. Reno, et. al. - 4:CV-97-0359 (M.D.PA.) -

LSCI Allenwood inmate Marc Ramirez, Reg. No. 27353-053, filed this action alleging an infringement on his First Amendment Rights. Main Justice, Civil Division has advised the U.S. Attorney's office in the Middle District of Pennsylvania that their office will handled the case.
