This paperback volume is extremely useful, and the new edition should be purchased each year.

Federal Civil Judicial Procedure and Rules. West. Issued annually. 1996 ed. approximately \$32.00.

Includes the Federal Rules of Civil Procedure; Multidistrict Litigation; Habeas Corpus; Motion Attacking Sentence; Evidence; Appellate Procedure; and Supreme Court Rules. This paperback volume is extremely useful, and the new edition should be purchased each year.

Federal Rules of Criminal Procedure for the United States District Courts practice comments by Michele G. Hermann. Clark Boardman Callaghan. 1980 - Updated as looseleaf.

Useful, but not required. For larger institution law libraries.

It is recommended that the institution law library establish a borrowing/lending relationship with a law library that maintains a full set of the CFR since information from other Titles may also be needed. A Available in CD-Rom (entire CFR) LawDesk. Lawyers Co-operative Pub. Co.

#### Digests:

West digests are the subject indexes to court decisions reported in the West Reporters listed above. Using the West topic and key numbers, these digests are essential case finding tools.

West's Federal Practice Digest 3rd. West. 1976-1989. 120 volumes. Approximately \$3780.00

West's Federal Practice Digest 4th. West. 1989 - Current.

These two digests provide access to federal court decisions from 1976 to date. If possible, the earlier West Federal Practice Digest 2nd should be maintained in the institution law library collection. If this is impossible, steps should be taken to establish a borrowing/lending relationship with a law library that holds this digest as well as all other federal digests.

Martindale-Hubbell Law Directory. Martindale-Hubbell. Issued annually. Approximately \$300 for Legal Directory volumes.

This is an expensive set listing 800,000 lawyers and law firms from 50 states and over 130 foreign countries. Given the cost of this set and the information it provides, one set per state prison system might suffice if provisions can be made to answer inmate requests for information from the single copy of this set.

State institutions may wish to purchase only the volume containing their state or substitute their state bar association's directory for the Martindale-Hubbell Directory.

#### Legal Research Guides

Legal research guides fall into two categories, Comprehensive Legal Research Guides and Basic Research Guides, and one guide should be selected from each category. If the size of the prison population is sufficient to warrant additional materials, and if the law library budget can be stretched to include such additional materials other titles from each category should be added to the collection.

#### A. Comprehensive Legal Research Guides (select one)

How To Find the Law by Morris L. Cohen, Robert C. Berring and Kent C. Olson. West 9th ed. 1989. \$32.50.

Excellent, in-depth guide to legal research. Appendix includes State Legal Research Guides and Bibliographies, a list of State Primary Legal Sources, Coverage of West Legal Reporters, Sources of Federal Regulatory Agency Rules, Regulations and Adjudications, and a Subject Guide to Selected Looseleaf Services. Also includes a name index, title index and subject index.

OR

Fundamentals of Legal Research by J. Myron Jacobstein, Roy M. Mersky and Donald J. Dunn. Foundation Press. 6th ed. 1994. \$36.50.

Excellent, in-depth guide to legal research. Appendix includes Table of Legal Abbreviations, State Guides to Legal Research, Legal Research in Territories of the United States, a listing of State Reports, Coverage of the National Reporter System (West Reporters) and a Chart on Legal Research Procedure. Good index.

#### B. Basic Research Guides (select at least one)

Finding the Law. An Abridged Edition of "How to Find the Law, 9th Ed." by Morris L. Cohen, Robert C. Berring and Kent C. Olson. West. 1989. \$21.95.

This is an abridged edition of the title listed under Comprehensive Research Guides.

Legal Research: How to Find and Understand the Law by Stephen Elias and Susan Levinkind. Nolo Press 3rd ed. 1993. \$19.95.

Excellent basic guide to legal research. This guide explains how to find and research cases and read statutes and administrative regulations.

'Legal Research Illustrated: An Abridgement of Fundamentals of Legal Research by J. Myron Jacobstein, Roy M. Mersky and Donald J. Dunn. Foundation Press. 6th ed. 1994. pap. \$21.95.

This is an abridged edition of the title listed under Comprehensive Research Guides.

Legal Research in a Nutshell by Morris L. Cohen and Kent C. Olson. West 5th ed. 1992. \$16.62

One of the West Nutshell series, this is a good intermediate choice between a comprehensive legal research text and a layperson's guide to legal research.

The Legal Research Manual (A Game Plan for Legal Research and Analysis) by Christopher G. Wren and Jill Robinson Wren. Adams and Ambrose Publishing. 2nd ed. 1986. pap. \$9.95.

A how-to manual for effective legal research and analysis. The Wren book stresses the process of legal research, includes flow charts, and emphasizes legal analysis. The appendix includes Other Research Sources, an Overview of Civil Procedure, Case Headnotes and the Digesting System, Briefing a Case, Answers to Shepardizing Exercises, West Digest Topics, Titles in the *United States Code*, Titles in the *Code of Federal Regulations*, Researching Legislative History, Definitions of Terms Frequently Encountered in Legal Research, and Translations of Foreign Words and Maxims Frequently Encountered in Legal Research.

Legal Research: A Self-Teaching Guide to the Law Library by W. William Hodes. National Institute for Trial Advocacy. 2nd ed. 1988. pap. \$15.00 (An optional instructor's manual is available for \$7.50.)

A series of six law library tours with exercises intended to illustrate the legal research process. This volume doesn't include sample pages or illustrations, so access to the materials discussed is essential to maximize its usefulness.

Legal Research -- Without Loosing Your Mind by C. Edward Good. LEL Enterprises. 1993. \$24.45.

The price of this volume Includes a Visual Aids Supplement with sample pages to illustrate the text. This is a good basic introduction to legal research using a folksy approach. The folksy approach does antagonize some readers. The author emphasizes the American Digest System and updating through the General Digests. Since most prison law libraries will use a state and/or regional and federal digests, this detracts from the usefulness of the digest section of the book.

Legal writing requires correct citation format. The official manual for legal citation format is the *Harvard Blue Book*, and the most current edition should be available in every institution law library collection.
