## U.S. Immigration and Customs Enforcement (ICE)

## Administration

The U.S. Immigration and Customs Enforcement (ICE), a bureau of the Department of Homeland Security (DHS), shares responsibility for enforcing immigration laws. ICE is responsible for processing and, if warranted, the accommodation of individuals awaiting immigration hearings and illegal aliens awaiting deportation. ICE activities include detention of aliens who have entered the United States illegally or have violated their immigration status. ICE Detention and Removal Operations (DRO) currently provides oversight to 24 Field Offices unroughout the United States. Aliens placed in removal proceedings may be detained in one of the ICE Service Processing Centers (SPCs), Contract Detention Facilities (CDFs) or in a local state facility utilized under an Intergovernmental Service Agreement (IGSA).
