## LITIGATION

### NEW CASES

Collier v. LeBlanc (SDC) Petition for Writ of Habeas Corpus claiming unlawful detention on account of allegedly improperly executed arrest warrant by U.S. Parole Commission. Also seeks order preventing transfer out of district during pendency of petition.

Foster v. Hood (SHE) Petition for Writ of Habeas Corpus contesting discipline sanctions.

Hunter v. Herrera (LOM) Petition for Writ of Habeas Corpus contesting DHO matter.

Jiminez v. United States (LOM) FTCA/Bivens complaint alleging dental malpractice.

McDavid v. Hood (SHE) Petition for Writ of Habeas Corpus contesting computation of good conduct time.

Rhonemus v. Warden (LOM) Petition for Writ of Habeas Corpus contesting Inmate Financial Responsibility Program.

Smith v. Jusino (SET) Petition for Writ of Habeas Corpus seeking credit for time spent during court order drug rehabilitation and CCC.

# SIGNIFICANT DEVELOPMENTS/APPEALS

Boehner v. Hood RDAP cases reported dismissed in December 2001 report have been appealed to the Ninth Circuit. Motion to consolidate has been granted and case is captioned Boehner v. Hood, 02-35025, (lead case). Court imposed expedited briefing schedule with oral argument slated for April 8, 2002, in San Francisco.

Carter v. United States (TRM) FTCA complaint alleging medical malpractice at FCI Terminal Island and MCC Chicago dismissed with prejudice for failure to file administrative claim within two years of alleged event. Plaintiff has filed notice of appeal.

Castillo v. United States (SDC) Settlement conference held in medical malpractice case. Plaintiff insisted on sentence reduction as part of agreement. Court clearly stated that was not an option.

Felix-Perez v. Acosta, et al. (SDC) Court dismissed former Warden Lathers with prejudice as part of her immunity motion. As a result, plaintiff's counsel decided against pursing any claim against current warden in Bivens case alleging sexual assault and battery.

Flowers v. United States and Flowers v. Finnerty, et al. (LOM) FTCA and Bivens complaints alleging assault, battery and constitutional violations. Settlement reached and filed. Dismissals of both actions filed January 23, 2002.

Friedman v. U.S. Bureau of Prisons (PHX) District Court approved \$500 settlement of Privacy Act lawsuit.

Jones-Heim v. Reese (DUB) District judge found in favor of defendants in Bivens complaint regarding DHO matter and summary judgement was issued in their favor.

Lopez v. United States (LOS) FTCA complaint involving inmate on inmate assault scheduled to start trial February 5, 2002.

Moreland v. Rothstein, et al. (SET) Inmate voluntarily dismissed Bivens complaint against Judge, AUSA, and Warden alleging denial of access to courts.

Murphy v. Hood (SHE) Ninth Circuit affirmed denial of RDAP Petition for Writ of Habeas Corpus which sought early release notwithstanding prior escape rendering inmate ineligible for CCC placement.

Sherrod v. Rardin (LOM) District Court granted Petition for Writ of Habeas Corpus complaining of DHO matter after inmate appealed original dismissal to Ninth Circuit.

Stewart v. Adams (LOM) Bivens/FTCA complaint alleging deliberate indifference and medical negligence. Settlement reached as to FTCA case during settlement conference. Bivens action to be dismissed when FTCA settlement is filed.

Wharton v. Hood (SHE) Ninth Circuit affirmed lower court's dismissal of Petition for Writ of Habeas Corpus arising from DHO action revoking 13 days of good conduct time. Appeal determined moot as inmate had been released.

## NEW INFORMATION ON ACTIVE PROSECUTIONS

#### MURDER

U.S. v. Figueroa (LOS) Trial for three inmate defendants charge with murder, assault with the intent to murder, and assault with intent to do bodily harm scheduled for August 13, 2002. (Inmate victim subsequently died from injuries sustained in assault.)

#### **ASSAULT**

- U.S. v. Guyton (LOM) Sentencing hearing continued to February 11, 2002.
- *U.S. v. Rios-Escobar* (VIM) Inmate on staff assault accepted for prosecution. Inmate stuck lieutenant in face and while being escorted and in restraints, inmate kicked an escorting officer in chest.

## **ESCAPE**

- U.S. v. Eaton (SHE) Escapee from FPC Sheridan pled guilty to charge January 31, 2002.
- U.S. v. Fischer (SHE) Inmate escape during transfer to CCC recently apprehended and in custody in Arkansas. Prosecution to be effected in Eastern District, Arkansas.
- U.S. v. Little (SET) Seattle CCC escapee pled guilty to escape and sentenced to 12 month consecutive term of incarceration.
- U.S. v. Mayhorn (PHX) CCC escape indictment dismissed for failure to prosecute. USAO may refile case.

Hand made clothing and mask designed for use in escape were discovered in two man cell at FCI Phoenix. USAO declined prosecution of inmate accepting responsibility for items due to length of his current sentence.

### CONTRABAND

- U.S. v. Davis (LOS) Inmate sentenced to 18 months with three years supervised release for possession of amphetamines and marijuana.
- U.S. v. Exum (TRM) Trial for inmate possessing heroin continued.
- U.S. v. Parrado-Herrera (PHX) Trial previously set for January 8 has been postponed.

## SEX OFFENSES

State of California v. Gaines Former FCI Phoenix inmate received 20 year sentence for sexual contact with minor. Facts of the offense were discovered through ITS at FCI Phoenix. Inmate completed federal sentence at USP Lompoc December 26, 2001.

- U.S. v. Mosequeda-Gonzalez (PHX) USMCFP report indicates inmate is capable of standing trial for sexually assaulting female officer. Inmate forcefully attempted to kiss staff while straddling and simulating sex act with officer. Inmate made admission that he was attempting to rape the officer.
- U.S. Attorneys Office has agreed to reconsider possible prosecution involving sexual contact with inmate by two former FCI Phoenix staff members.


