**Background Narrative:**

ON 9/8/08, INMATE [REDACTED] SUBMITTED A WRITTEN STATEMENT INDICATING THAT SHE HAD BEEN SEXUALLY INVOLVED WITH OFFICER ERIC CONRAD. INMATE [REDACTED] STATED THAT THIS RELATIONSHIP STARTED IN MARCH 2008 AND LASTED FOR A PERIOD OF THREE MONTHS. SHE STATED THAT SHE HAD SEXUAL RELATIONS WITH OFFICER CONRAD APPROXIMATELY FIVE TIMES. SHE ALSO INDICATED THAT OFFICER CONRAD HAD TAKEN PICTURES OF HER USING HIS PERSONAL CELLULAR PHONE AND HAD FORWARDED THE PICTURES (VIA CELL PHONE) TO HER (INMATE [REDACTED]) DAUGHTER'S CELLULAR PHONE. ADDITIONALLY, INMATE [REDACTED] ALLEGED THAT OFFICER CONRAD BROUGHT FOOD TO HER AND THAT SINCE THE RELATIONSHIP ENDED HE HAS MADE THREATS AGAINST HER AND HER FAMILY. INMATE [REDACTED] ALSO STATED THAT SHE WAS IN FEAR FOR HER SAFETY DUE TO OFFICER CONRAD'S WIFE WORKING HERE AT THIS FACILITY.

ASSIGNED BY INSPECTOR MARTIN. AS A RESULT OF THIS INVESTIGATION ANALYSIS OF THE EVIDENCE, THERE IS INSUFFICIENT EVIDENCE TO SUSTAIN THE ALLEGATION OF SEXUAL BATTERY OR SEXUAL MISCONDUCT AGAINST OFFICER ERIC CONRAD. HOWEVER, THERE IS SUFFICIENT EVIDENCE THAT OFFICER ERIC CONRAD HAS VIOLATED CHAPTER 33-208.002(26)(STAFF/INMATE RELATIONSHIP), FLORIDA ADMINISTRATIVE CODE. ON SEPTEMBER 8, 2008, WARDEN JOYCE ARNOLD TERMINATED OFFICER CONRAD FROM HIS POSITION AS CORRECTIONAL OFFICER WITH GADSDEN CORRECTIONAL FACILITY. ON NOVEMBER 14, 2008, THIS CASE WAS UPGRADED TO AN A-CASE AND WAS REASSIGNED FROM GADSDEN CORRECTIONAL FACILITY INSPECTOR KENYA GOLDEN TO SENIOR INSPECTOR JO D. TURNAGE. MR. HARRISON POOLE, GADSDEN COUNTY STATE ATTORNEY'S OFFICE, WAS CONTACTED AND DECLINED PROSECUTION DUE TO A LACK OF WITNESSES AND EVIDENCE, RECOMMENDING THE CASE BE HANDLED ADMINISTRATIVELY. \*\*\*\*\*2/23/09 C.
