

## Titusville Police Department

Russ, here is what I was able to retrieve from city hall. The information is not in any order, but you can at least make some sense of it.

The incidents highlighted in yellow are the injuries prior to September of 2000 when we received our original seven (7) test TASERS. You have to keep in mind only seven of us had the TASERS for the first several months after the initial training. Full implementation did not occur for several months. Injuries prior to the TASERS are marked in red pen and are the incidents where a TASER would have possibly allowed the officer to stand off and not get injured. There were 39 documented instances where the TASER would have stopped the subject's violent action causing the officer to get injured in the process of arrest. Since the TASER program only three documented instances of injury to officers have occurred, a dramatic decrease. We do not issue TASERS to some officers who may work off the road so those who were injured may not have had access to a TASER at the time of the incident where the officer was injured.

Officer "T" was injured during an arrest and had to receive two months no duty- Four months light duty. The cost was 6,000 dollars medical. He stated, " I wish I had a TASER, the outcome would have been different."

Officer "F" injured his right thumb during an arrest. Three months light duty and 8,000 dollars medical.

Officer "S" wrestled a suspect hurting her shoulder. Two months light duty, therapy three times a week and no duty status for six months. Total cost to this point 200,000+ dollars.

Officer "T" bitten on wrist during an arrest, 2,000 dollars in medical and out of work for two days.

You can probably figure most of the highlighted injuries cost the city at a minimum of 2,000 dollars per injury and that is going low on the estimates.
