On this date 3/24/04 evidence was found showing a possible relationship between a WCCW female AC Cook and Inmate [REDACTED]. This evidence consisted of letters mailed from outside the institution and notes. Inmate [REDACTED] was questioned and admitted that the evidence seized was from the AC Cook in question. The initial review of the evidence and questions answered by the inmate do not show any physical contact at this point. The fact finding investigation will continue and updates will be sent as required.

SUBJECT: POSSIBLE STAFF MISCONDUCT RE: AC COOK LAURA GILBERT

SYNOPSIS: On 3/24/04 WCCW I&I was contacted by MSU Correctional Officer (CO) Clover who stated that Inmate (I/M) [REDACTED] had been caught leaving the MI Kitchen with a paper sack of food. CO Clover also reported that I/M [REDACTED] had approached her soon after and said that the food was a payoff for I/M [REDACTED] transporting messages from AC Cook Laura Gilbert (see picture attachment 1) to I/M [REDACTED] (see picture attachment 2). A search of I/M [REDACTED] room was conducted and nine (9) typed and handwritten notes were taken into evidence (see attachments 3 thru 11) also taken into evidence were four (4) letters (see attachments 12 thru 15) addressed to I/M [REDACTED] and mailed from an address in Tacoma Washington. A review of the notes and letters showed that they were of a close and personal nature saying how much the writer loved I/M [REDACTED] and how she longed to be with her. An initial interview was conducted with I/M [REDACTED] who admitted that some of the documents taken from her room were from AC Cook Gilbert. WCCW Superintendent Belinda D. Stewart was notified and gave permission to continue the investigation. AC Cook Gilbert was initially interviewed on 3/24/04 and after denying all allegations to a certain point in the interview then stood and left the I&I Office when asked if she had an Arabian horse (This horse was mentioned in one of the confiscated typed notes). Notification per policy was made to the appropriate offices of the investigation by E-mail.

INVESTIGATIVE INTERVIEWS:

Inmate [REDACTED] was interviewed on 3/25/04 and stated that she had heard the notes were being transported from other inmates and had no first hand knowledge. Inmate [REDACTED] did report that the relationship was a poorly kept secret.

Inmate [REDACTED] was interviewed on 3/29/04 and was presented with a nine (9) copies of the papers confiscated from her room, marked evidence 1 thru evidence 9 (see attachment 16). I/M [REDACTED] stated that all but one (1) and six (6) were from AC Cook Laura Gilbert. I/M [REDACTED] stated that none of the letters mailed from the Tacoma address were from AC Cook Gilbert but were rather from a friend she knew from Oregon. When questioned if she ever called this friend she stated that she had recently, however a review of I/M [REDACTED]'s phone records show no calls outside of family and lawyers. When asked if this friend could be contacted I/M [REDACTED] was unable to supply a phone number.

NOTE: Contact was attempted with the residents at [REDACTED] (the return address on the confiscated letters) on four separate occasions at varying times during the day/evening. Negative results were achieved even when the driveway was filled with automobiles. Business cards were left on two occasions with requests to receive calls with negative results. The United States Postal Inspectors were contacted and a FAX with names of residents receiving mail at that address was received (see attachment 17) none of the names listed matched the name on the return address.

AC Cook Michelle Foster: was interviewed on 3/30/04 and sent E-Mails (see attachments 30-31) on that date and 4/12/04 stating that she had observed AC Gilbert giving Inmate [REDACTED] a sack on one occasion and on at least three other occasions had seen Inmate [REDACTED] and AC Gilbert sitting in the kitchen at a table with a sack on the table between them. AC Foster also reported that she had observed AC Gilbert and Inmate [REDACTED] talking at the backdoor of the kitchen on several occasions when I/M [REDACTED] was not working.

Recreation Leader Heidi Sheridan: sent an E-Mail on 3/25/04 (see attachment 32) in which she states she recalled seeing AC Gilbert in the Craft Room on more than one occasion and recalled seeing her in the craft room clerk's office with Inmate [REDACTED] at least one time.

Correctional Officer M. Cowens: wrote a incident report date 3/25/04 (see attachment 33) and reported that on 3/18/04 AC Cook Laura Gilbert entered the gym and walked into the craft room. Inmate [REDACTED] was in the craft room.

AC Cook Laura Gilbert: AC Cook Gilbert was initially interviewed on 3/24/04 and gave negative responses when asked if she was in a relationship with I/M [REDACTED]. When asked questions about the mention of a horse in one of the notes found in I/M [REDACTED]'s property AC Gilbert stood and left the room. AC Cook Gilbert was reinterviewed on 4/2/04 with Union representation present. The following questions/answers were given/received:

- Were you involved in a relationship with I/M [REDACTED] -No
- Have you told personal information to inmates - Yes, but could not give any examples
- Have you ever passed any notes to inmates - No
- Have you ever written any letters to inmates and mailed them - No
- Do you have any horses - Yes - a Blood red Bay
- Do you have an Arabian Horse - No
- Have you ever had a horse by the name JF Morificent or Maury - No
- **NOTE at this point in the interview AC Cook Gilbert asked to talk to her Union Representative in the hall upon their return she acknowledged that she did indeed have an Arabian by the name mentioned.**
- Have you ever given Inmate [REDACTED] extra sacks from the kitchen - No but might have given her sugar and coffee for the gym
- Have you ever allowed inmates to take food from the kitchen - No
- Have you been in the gym while working - Yes but outside the craft room maybe more than once.

When asked if she would submit to a handwriting exemplar to be submitted to the Washington Crime Lab she declined and stated that she didn't think it would clear her even if it came back OK.

INVESTIGATIVE RESULTS: In the course of this investigation facts mentioned in the notes and letters were examined and investigated for any ties to AC Cook Laura Gilbert the results are as follows:

- In a note taken from I/M [REDACTED] property (see attachment 6) an Arabian Horse is mentioned along with many facts that would be unknown to the layman about that type of horse. A Check of the National Arabian Horse Association showed the horse to belong to a Jamie Jacques of Port Orchard Washington. A site visit was made to the address of the horse according to the registry and was informed by a male at the ranch that the horse had been sold to a lady working at the prison but that if I called his girlfriend she could tell me more. A call was placed to

- 206-898-6574 and a Ms. Jacques answered the phone and stated that she had sold the horse in question to a Laura Gilbert of Port Orchard on or about 11/30/03
- In a note taken from I/M [REDACTED]'s property (see attachment 3) It is written that "After a while, officers that worked in the gym told me that you told them of our relationship, I got so freaked out, I mean me in my position." This phrase would suggest that the writer is a staff member. Later in this note she mentions her little friend had come and apologized to her. The dual relationship suggested by this note again lends credence to the dual relationship between AC Cook Gilbert and Inmates [REDACTED] and [REDACTED]
 - In another note taken from I/M [REDACTED]'s property (see attachment 7) it is mentioned that "they need to talk" and suggests Wednesday evening as a good time for the writer. Wednesday is the only evening that AC Cook Gilbert works all other days she works from five in the morning to one in the afternoon.
 - In the same note as above it is mentioned that she will see I/M [REDACTED] in a couple of days, again giving evidence that the writer is a staff with days off and therefore absent from the facility.
 - In another note taken from I/M [REDACTED]'s property (see attachment 5) the writer of the note says she had missed I/M [REDACTED]'s birthday. I/M [REDACTED]'s birthday was 12/29/03 a Tuesday and one of AC Cook Gilbert's days off.
 - In this same note a messenger is mentioned towards the end giving rise that I/M [REDACTED] might have been transporting notes for AC Cook Gilbert, as suggested by several inmates.
 - In a card written from the Tacoma Address (see attachment 12) and mailed into WCCW the writer says, "when you looked at me the way you did the other day (when we finally spoke) this letter suggests that the writer has contact with I/M [REDACTED]. I/M [REDACTED] stated this was on an astral plane and not from AC Cook Gilbert. All Letters that are dated are from April and on a day that AC Cook Gilbert has off.
 - In the above card the initials C.F. are used as in the notes identified as being from AC Cook Gilbert by I/M [REDACTED]. I/M [REDACTED]'s Inmate Girlfriend is [REDACTED] who when interviewed denies all knowledge of the relationship between the two however reading the letters and notes gives one the impression that I/M [REDACTED] kept the two relationships distant.
 - In another card (see attachment 13) the writer states "God I hate it when I have to leave you behind." Giving the impression that the writer has contact with I/M [REDACTED] which the individual that I/M [REDACTED] claims does not.
 - In a card sent from the Tacoma address (see attachment 13) the writer says "it bothers me when you look at me like you're unsure about something, don't be my feelings have never changed." This again hints that the writer had close contact with I/M [REDACTED]

CONCLUSIONS: Base upon interviews, evidence collected and examined the following facts are submitted:

- There is a preponderance of evidence to suggest that the letters sent from the Tacoma Washington address did in fact originate from AC Laura Gilbert. These letters have been submitted (4/9/04) to the Washington Crime Lab and will be compared with known examples of AC Cook Gilbert's handwriting. Ms. Gilbert refused to submit a handwriting exemplar.
- Two Inmates [REDACTED] and [REDACTED] have stated they received and then identified notes written by AC Cook Laura Gilbert now held in evidence by WCCW I&I. Many of these notes are of a close and personal nature.
- Multiple staff have stated that they have observed AC Cook Laura Gilbert in conversation with Inmates [REDACTED] and [REDACTED] outside the scope of her responsibilities in the kitchen.
- AC Cook Gilbert lied about owning a horse mentioned in a note taken from Inmate [REDACTED]
- AC Cook Gilbert denies giving food to inmates though both inmates and staff have observed it.

OK, HERE IT IS AND BY THE WAY, THANK YOU FOR GIVING ME THE OPPORTUNITY TO EXPLAIN MYSELF TO YOU. MOST PEOPLE PROBABLY WOULD HAVE SAID "F" "U". FIRST OF ALL, AND MOST IMPORTANT WHEN I TELL SOMEONE I LOVE THEM, IT MEANS FOREVER, I DON'T SUDDENLY STOP WHEN SHIT HITS THE FAN. SO, DON'T EVER, EVER THINK THAT I DON'T LOVE YOU ANYMORE, BECAUSE, I DON'T LOVE VERY OFTEN. IN FACT MOST PEOPLE SEEM TO LOVE SO FREELY THAT IT DOESN'T SEEM SO SACRED. THAT JUST ISN'T MY STYLE.

I WANT TO TELL YOU THAT I HEARD HORRIBLE RUMORS OF YOU AND "C" "F" AND WAS A FOOL AND LOOKED STUPID FOR EVEN BEING NEAR YOU. I HEARD ALL KINDS OF STATEMENTS OF YOU AND "HER" IN HER ROOM AND SOMEONE TOLD YOU THAT YOU SHOULD WASH UP AFTERWARDS AND YOU SUPPOSEDLY SAID "THAT WAS SOME GOOD PUSSY" AND THEN PLAYED CARDS WITH YOU'RE FRIENDS. NO, THIS WASN'T "MY LITTLE FRIEND" THAT TOLD ME THIS EITHER. THIS PERSON WAS A SHORT BLACK PERSON. I JUST HEARD SO MUCH AND THE FACT THAT YOU GOT SO DEFENSIVE WAS A RED LIGHT TO ME. I JUST FIGURED YOU GOT TIRED OF "WAITING" ON SOMEONE LIKE ME. SO, THE REASON I TURNED MY HEAD WHEN I SAW YOU IS BECAUSE I WAS "DISGUSTED" AND HURT. THIS WAS THE ONLY REASON. I WANTED TO FORGET I EVER LOVED YOU. BUT, DURING THIS TIME I NEVER STOPPED LOVING YOU. I JUST KEPT ON THINKING, WHAT DIDN'T I DO RIGHT? BESIDES, EVERY OTHER RELATIONSHIP TURNED OUT THIS WAY, BUT, AT THE SAME TIME I JUST DIDN'T WANT TO BELIEVE IT, THE WAY I FELT ABOUT YOU WAS LIKE NOTHING EVER BEFORE, I KNEW IT WAS REAL. SO, I KEPT DENYING THE CRAP.

AFTER A WHILE, OFFICERS THAT WORKED IN THE GYM TOLD ME THAT YOU TOLD THEM OF OUR RELATIONSHIP. I GOT SO FREAKED OUT, I MEAN, ME IN MY POSITION, REALLY, THINK ABOUT IT. I FREAKED AND JUST WAS SO TIRED OF ALL THE LIES AND RUMORS THAT I WOULD HAVE DONE ANYTHING TO GET THEM OFF OF OUR BACKS. I WOULD GO HOME AND CRY. I DIDN'T KNOW WHAT TO DO, I COULDN'T GET ADVICE FROM ANYONE. THEN, ONE DAY "MY LITTLE FRIEND" TOLD ME SHE WAS SORRY FOR ALL THE PROBLEMS SHE HAD CAUSED ME IN THE PAST. I WAS VERY STANDOFFISH BUT ACCEPTED HER APOLOGY AFTER SOMETIME. I WAS VERY CAUTIOUS BUT, I AM WILLING TO FORGIVE A PERSON. WE BEGAN TO TALK AND SHE EXPRESSED SOME ISSUES ABOUT HER HUSBAND AND DAUGHTER AND I BECAME AN EAR AND WAS FOR SOMETIME. (I NEVER LIED TO YOU ABOUT THAT) AS I TOLD YOU BEFORE. AS WE TALKED, I BEGAN TO THINK THAT MAYBE THIS WAS A GOOD IDEA BECAUSE "WE" WERE SO SICK OF THE RUMORS OF US THAT THIS MIGHT TAKE SOME "HEAT" OFF OF US. (AS I TOLD YOU). I DIDN'T LIE ABOUT THIS. AS TIME WENT BY SHE BEGAN TO PLAY HER "GAMES" AND I WAS STUPID FOR NOT GETTING OUT OF THE SITUATION. SHE BEGAN TO APPROACH ME AND I WOULD SAY NO, TIME & TIME AGAIN. SHE WOULD ASK ME IF YOU AND I WERE TOGETHER AND I WOULD TELL HER THAT WE HAD FEELINGS FOR EACH OTHER AND THAT YOU WERE VERY PASSIONATE TOWARDS ME. FAR MORE THAN SHE WAS. THAT DEFINETLY BOTHERED HER AND I COULD SEE NO END TO THE INFATUATION THAT SHE TRANSPIRED TOWARDS ME. THE ENTIRE TIME IM THINKING IM STUCK IN A HOLE THAT IM NOT SURE HOW TO GET OUT OF AT THIS POINT, THAT IS WHEN THE THREATS BEGAN, NOT AGAINST ME BUT AGAINST YOU AND I KNOW SHE SAID SOME THINGS TO YOU AND TRIED TO PICK FIGHTS WITH YOU AND I AM SO SORRY FOR ALL OF THIS. I KNEW YOU COULD HANDLE IT. GOD, WAS I A FOOL. EVERYTHING WENT TO HELL AND I DIDN'T KNOW WHAT TO DO. SHE WOULD'T LEAVE YOU ALONE FOR NOTHING AND BELIEVE THAT SHE COULD DO WHAT SHE WANTED WITHOUT GETTING INTO ANY TROUBLE AT ALL. SHE BECAME SO POSSESSIVE AND I COULD SEE NO END TO IT. THE WHOLE TIME I NEVER STOPPED THINKING OF YOU AND WHAT YOU WERE THINKING. I TRIED TO SPEAK TO YOU AND EVERY TIME I TURNED AROUND SHE WAS THREATENING TO HURT YOU. SHE BECAME SO INFATUATED WITH ME THAT I WAS DESPERATE TO END THE SITUATION. SHE BEGAN TO TALK ABOUT MEETING WITH ME WHEN SHE GOT OUT, THIS FREAKED ME OUT. BUT THE THREATS BEGAN AND I GAVE IN AND LIED TO HER TO EASE HER MIND AND FINALLY SAID YEAH, ILL SEE YOU WHEN YOU GET OUT. YOU DON'T UNDERSTAND WHAT TRANSPIRED, SHE BECAME SO

EVIL . THE ENTIRE TIME ALL I WANTED TO DO WAS RUN TO YOU, EVEN THOUGH I WAS HURT AND DISGUSTED WITH YOU AND C.F. OH, SHE HASN'T BEEN IN THE PICTURE FOR SOMETIME SO, THAT IS NOT THE REASON I AM TALKING TO YOU. I TOLD HER THAT I DON'T HAVE FEELINGS FOR HER. SHE BEGAN TO REALIZE THAT I WASN'T GOING TO BUDGE AND I TOLD HER TO JUST GO AND BE HAPPY. SHE THEN WENT TO TALK TO HER PRESENT "FRIEND" AND LIVED HAPPILY EVER AFTER (YEH, RIGHT). I HAVEN'T LIED TO YOU AS YOU THINK. BUT, I DO UNDERSTAND HOW YOU COULD THINK THIS WAY. I DON'T HAVE IT IN ME TO LIE TO SUCH A WONDERFUL WOMAN LIKE YOU. I FEEL SO MUCH GUILT ABOUT THIS WHOLE THING EVEN THOUGH "I NEVER CHEATED ON YOU" MOST IMPORTANTLY " I NEVER EVER CHEATED ON YOU WITH MY HEART" MY HEART HAS ALWAYS BELONGED TO YOU. IM NOT USING YOU OR ANYBODY FOR ANY REASON. I JUST CAME TO MY SENSES AND REALIZED THAT YOU ARE AN INCREDIBLE WOMAN THAT ONLY COMES AROUND ONCE IN A LIFETIME, I AM NOT USING YOU TO GET BACK AT HER. I AM ONLY SEEING WHAT A FOOLISH PERSON I AM IF I DON'T TELL YOU NOW HOW MUCH I LOVE YOU AND WILL ALWAYS LOVE YOU FOR THE REST OF MY LIFE, YA KNOW, I CAN SEE IT IN YOU'RE EYES, AND "WE" KNOW THAT IT WOULD BE THE BIGGEST MISTAKE OF OUR LIVES TO LEAVE EACH OTHER NOW. I AM WILLING TO DO WHATEVER IT TAKES TO GET IT BACK TO WHERE WE WERE BEFORE. I KNOW YOU LOVE ME, I CAN FEEL IT IN MY ~~HEART~~ HEART AND SO CAN YOU. ADMIT IT. I NOW KNOW THAT IF YOU STOP LOVING ME THAT I WILL NEVER LOVE ANYONE EVER AGAIN BECAUSE I WILL LIVE WITH THAT FOOLISH MISTAKE FOR THE REST OF MY LIFE, KNOWING THAT THE CAUSE WAS ME AND MY STUPIDITY. I DESERVE ALL OF THE DIRTY LOOKS FROM "CF" AND YOU CAN TELL HER THAT. BUT, I AM THE SAME SWEET PERSON WHO YOU FELL IN LOVE WITH SINCE THE DAY WE MET. I BELIEVE THAT THE WHOLE PROBLEM IS PEOPLE INVADING OUR RELATIONSHIP AND WE SHOULD BE LISTENING TO EACH OTHER AND NOT THESE LOSERS WHO REALLY DON'T CARE ABOUT YOU AND I. SWEETHEART, I NEVER CHOSE HER OVER YOU, ITS ALWAYS BEEN YOU. PLEASE, IM BEGGING, LETS START OVER. I DON'T WANT TO DO THIS HERE, I DON'T WANT THE CRAP TO START AGAIN. LET'S BE QUIET. I WANT TO WAIT FOR YOU AS I HAVE BEEN. PLEASE DON'T LEAVE ME, I COULDN'T LIVE WITH MYSELF. PLEASE TELL "C F" THAT I AM SORRY AND I WILL NEVER HURT YOU AGAIN. I WANT YOU TO TRUST ME AND I WANT TO TRUST YOU. I LOVE YOU SO MUCH. I WANT TO DO ALL OF THE THINGS WE TALKED A BOUT DOING TOGETHER. I LOVE YOU.....

Hi, sweetheart. I know you got my last note yesterday. I'm quite sure it put a smile on your face and then some. When I write to you it just flows and the truth about you and I and how I feel just comes out. You know what? When I saw you yesterday at breakfast, god, how do I put it into words? Why is it every time I see you or you are near me that I seem to lose control inside? Gosh, if you only knew what you do to me. Whenever I see you or you are near me I become so turned on by you, I mean something happens to me that I can't explain. Do you know what I mean? I think you do. I wish I could just walk up to you and wrap my arms around you and look into your beautiful eyes and caress your hair and tell you how much I love you. I just can't stand it, it drives me crazy that I can't show you how I really feel. But, I know you have a pretty good idea. I want to tell you that, yes I do think of the fact that you have kids. Just because I don't say all of the things maybe I should doesn't mean I'm not thinking of all of the important things. I sure would like to meet your kids. I'm sure they are as adorable as you are. I forget their names and ages, only because I'm not good with names. I do care and would like to know. Sweetie, I think of a lot of things about you and I actually am a thinker. I think a lot. I know it's hard to believe, but, I really am. Thank you for the note, it was sweet as always and was expressive as always. When I read your notes, I seem to feel all of your words, know what I mean? So, how are you feeling? are you ok? I'm still worried a bout you because of the fact that I hurt you so bad. I'm mad at myself and will be for a long time. Please don't tell me not to be because it's the truth and it's just something I'm going to have to live with for a while. What does C.F. think a bout all of this? Oh, the answer to your question is his name is JF Morificent but I call him Maury and sometimes Maury Povich. He will be 3 on May 1 ST and he is a Straight Egyptian Arabian gelding. He is a chestnut with a white star and stands at almost 15.2 hands high. He is very tall for his age since arabians take quite a while to mature. Did you know that only 3% of arabians are Straight Egyptian arabians? I was lucky to come across him. I actually rescued him and he wasn't looking to good. I have been feeding him Allegra, to fatten him up, its a senior feed that's fattening. What a difference it made. He needs work, but I got him to where he is ok to ride, but I could use some help. I don't have the time to go out their everyday and train him but, I do give him a lot of love and attention. I need to go now but I won't go far. I will always love you, babe. There is no back and forth shit either, I have always been here waiting on you, it has always been you and no one else. I have always been committed to you and will always be, its me and you sweetie. I'm here for you always. Write me, I love you.....me ...

April 9, 2004

I/M [REDACTED] stated that she had not pursued the relationship but rather it had been AC Cook Gilbert who had been the initiator. I/M [REDACTED] also reported that she had attempted to break it off with AC Cook Gilbert and had for a while but then the notes had begun again. I/M [REDACTED] denied that I/M [REDACTED] had transported notes for AC Cook Gilbert and denied seeing Ms. Gilbert in the MI Gym on weekends. I/M [REDACTED] stated she would rather not take a polygraph and that she just wanted this to be over. I/M [REDACTED] did state that there had been a rivalry between her and Inmate [REDACTED] for AC Cook Gilbert, which had resulted in animosity between the two inmates. I/M [REDACTED] stated that the relationship between I/M [REDACTED] and AC Cook Gilbert had gone on for over a year.

Inmate [REDACTED] was interviewed on the 7th and 12th of April 2004 both times I/M [REDACTED] was reluctant to talk but did turn over a card and 9 pieces of paper (see attachments 18-27) including drawings and horoscopes which she claims were given to her by AC Cook Laura Gilbert. I/M [REDACTED] stated that her relationship lasted over a year and a half and hinted on physical contact while in the kitchen. Two notes recovered from her property (see attachments 28-29) were also identified by her as being given to her by AC Gilbert. I/M [REDACTED] stated that the relationship ended when she began to see Inmate [REDACTED].

Inmate [REDACTED] was interviewed on 4/7/04 and stated that she knew that AC Cook Laura Gilbert liked her girlfriend I/M [REDACTED]. I/M [REDACTED] related that she grew tired of AC Gilbert chasing her friend so approached Ms. [REDACTED] and told her that she [REDACTED] would take AC Gilbert into the freezer and beat her ass if she didn't leave her alone. NOTE: AC Gilbert never reported the threat by [REDACTED].

Inmate [REDACTED] was interviewed on 3/24/04 and 3/25/04 both times I/M [REDACTED] related that she had not passed notes between I/M [REDACTED] and AC Cook Gilbert. I/M [REDACTED] also stated that she would never say anything bad about AC Gilbert because she was her friend. I/M [REDACTED] was reinterviewed on 4/8/04 and she stated that she did know that there was a relationship between Inmates [REDACTED] and [REDACTED] because she saw them together a lot in the kitchen and because of inmate talk. I/M [REDACTED] also stated that she had seen them in the gym together on several occasions.

Inmate [REDACTED] was interviewed on 4/8/04 and stated that while working in the kitchen she had observed AC Cook Gilbert exit the back door to the kitchen and talk with I/M [REDACTED] who was not working at the time and had walked up from MSU. I/M [REDACTED] stated that these conversations had lasted from 5 to 10 minutes. I/M [REDACTED] also said this was observed by AC Cook Michelle Foster.

Inmate [REDACTED] was interviewed on 4/8/04 and stated that while working in the MI Gym she had observed AC Cook Laura Gilbert enter the Gym, she then stated that I/M [REDACTED] left the gym and returned a few minutes later with Inmate [REDACTED], AC Gilbert, and Inmates [REDACTED] and Vanburen then entered the craft room's office and closed the door. I/M [REDACTED] stated that she then left not feeling comfortable with what was going on.

Inmate [REDACTED] was interviewed on 3/25/04 and reported that she had heard that there was a relationship between AC Cook Gilbert and Inmate [REDACTED] and that many other inmates knew it to be true. I/M [REDACTED] stated that she felt the reason that AC Gilbert would let inmates take food from the kitchen was the fact she was afraid that someone would tell on her if she stopped them. I/M [REDACTED] reported she had once taken a large piece of ham from the kitchen with the knowledge of AC Gilbert.



Conclusion:

Laura Gilbert cannot be identified or excluded as the writer of the questioned writings. There are indications that she is the writer of the hand printing that is a mix of upper and lower case letters.
